Companies are finding ways to reuse umbrellas or rent them out as an alarming amount of them has been thrown away. About 120 million to 130 million umbrellas, roughly the population of Japan, are purchased every year in the country, according to an estimate by the Japan Umbrella Promotion Association.

A survey conducted in May 2022 by Weathernews Inc., a meteorological information provider, showed that people in Japan possessed 4.2 umbrellas per person, on average. The survey showed that people tend to have more umbrellas in and around urbanized areas of the Kanto and Kansai regions. Separate statistics have shown that people walk fewer steps in the countryside than in urban areas, where they move around more often 11 means of public transportation than in private cars.

Combined, the results show a typical scene of urban consumer <u>12</u>: people caught in a sudden downpour are apt to buy a cheap umbrella at a convenience store. These realities provided the inspiration for umbrella-sharing services, which are expanding their operations mostly in urban areas.

I-Kasa, a provider of such services, has placed spare umbrellas at about 1,200 depots at train stations and other major facilities across 14 prefectures in Japan. "Kasa" means "umbrella" in Japanese. The umbrellas can be rented via a smartphone app for only 110 yen per 24 hours. The umbrellas have a return rate of 99.5 percent, the official said.

Different municipalities have different garbage separation policies when it comes to umbrellas. It is, at any rate, difficult to recycle umbrellas because they have metal frames. Ca Et La, a Tokyo-based umbrella manufacturer, has therefore come up with "+TIC" (Plus-tic), an umbrella made entirely of plastic. The product, being flexible, does not readily snap in a rainstorm. It also does not succumb to rust and can be discarded as plastic waste.

Meanwhile, fashion brands have created bags and other products upcycled from broken vinyl umbrellas. Fashion brand, Plasticity, has so far repurposed about 30,000 vinyl umbrellas, using them for tote bags and other products. The creator said, "Making bags alone does not eliminate wasted umbrellas, but I think things could change by using the power of those who sympathize with our products and concept."

A multiple-institute effort using computer graphics and DNA technology reproduced the assumed features of a woman who was likely a person of noble birth 1,600 years ago. Seven research institutes, including Tohoku University, worked with Yonezawa City's board of education to reproduce her whole body through such methods 16 DNA analysis and \*forensic facial reconstruction.

"An image and a video of the re-created model show that 'Himiko of Okitama' had \*droopy eyes, a flat nose, and straight black hair when she was alive, features that indicate she was a direct ancestor of modern people," said the researchers. Her skin color and hair type were determined based on genetic data from her \*skeletal remains, which were uncovered in 1982 from the Totsukayama burial mound group in Yonezawa's Asagawa district. About 200 graves are located around the foot of Mount Totsukayama in Yonezawa, which is part of the Okitama area.

Himiko's bones were found in a box-shaped stone coffin in the No. 137 Totsukayama grave, built from the latter half of the fifth century,  $\boxed{17}$  a long-tooth comb and a small knife. A Dokkyo Medical University study found that she was 143 to 145 centimeters ( $\nearrow$ ). She is estimated to have died at around 40 years old.

The  $(\checkmark)$  project started after Tohoku Gakuin University excavated the Haizukayama burial mound site in Kitakata, in neighboring Fukushima Prefecture, in fiscal 2017. The bones of a man 18 50 or older were unearthed there. Nuclear DNA was sampled from the ancient woman's teeth for comparison with the man's remains. The study found that 96 to 97 percent of her genetic information was well preserved.

A professor of Japanese archaeology at Tohoku Gakuin University, who headed the project, said, "We obtained nearly all of her nuclear DNA, or humankind's blueprints. Such abundant information rarely remains in old human bones." The National Museum of Nature and Science in Tokyo was commissioned to 19 her nuclear DNA.

The right side of the woman's skull had been lost, and the \*nasal bone was not found. But the study could show how she likely clenched her teeth, providing a better understanding of her dietary habits and lifestyle. Her teeth were found worn down with apparent signs of \*temporomandibular joint dysfunction. The conditions seemingly resulted from her chewing style and other habits, and her jaw was distorted slightly leftward. The "drooping eyes" conclusion was based on her skin's thickness.

The National Museum of Nature and Science's analysis showed that her hair was straight and black, her skin was brown or blackish brown, and her eyes were a color between black and brown. She was a descendant of the people who moved from the

Chinese continent during the Yayoi Pottery Culture Period (1000 B.C.-A.D. 250).

But some characteristics typical of people from the earlier Jomon Pottery Culture Period (about 14500 B.C.-1000 B.C.) were also identified in the woman's remains. An assistant professor of forensic medicine at Tohoku University's Graduate School of Dentistry said, "The Jomon people are said to have had \*craggier faces and prominent noses, but her nose was flat. Relatively large eyes and single-fold eyelids were added to her reproduction."

A professor at Tohoku Gakuin University said that there is a possibility that Himiko and the man in what is now Fukushima Prefecture may have known each other. He said, "With the advanced radiocarbon (C14) dating technology, an analysis of the human remains from Haizukayama and Totsukayama revealed the two belonged to the same period. She resembles us, suggesting she is our direct ancestor," he continued. "The research outcome is extremely important, and we wanted to share it with local people through imaging in an easier-to-understand way."

Many people believe that they need to multitask in order to keep up with the demands of modern life. However, is it true that taking on multiple tasks at once will really increase productivity and efficiency?

Multitasking is not the best way to manage a busy workload. It can result in reduced productivity and lower-quality work. It is important to understand why multitasking is not the best solution and what you should do instead.

Many people think that multitasking means being able to do many tasks at the same time, such as listening to music while working on a report or talking on the phone while typing an email. However, this is a widely held misunderstanding. Multitasking refers to the process of switching between tasks quickly in an effort to complete them all in a  $\frac{(1) \text{ time } (2) \text{ of } (3) \text{ period } (4) \text{ shorter } (5) \text{ temporary})}{1}$ . According to a neuropsychologist, "When we think we're multitasking, most often we aren't really doing two things at once. Instead, we're doing one action after another quickly, or task-switching."

For instance, someone may be trying to complete a report while attending an online meeting and responding to emails. In this case, they may quickly switch between these tasks,  $\frac{(1)}{2}$  one 2 to take 3 for 4 working 5 on) a few minutes, then switching to the next, then back to the first, and so on. While you are doing this, your brain must refocus each time, which can consume a lot of mental energy and time. This can lead to lower-quality work that takes more time to complete.

In fact, studies have shown that multitasking has a significantly negative impact on work quality and overall performance. If you would like to improve your work performance, it is good to prioritize your tasks and focus on one at a time  $\frac{(1)}{3}$  you (2) can (3) that (4) so (5) to) avoid dividing your attention.
